#### Council Members:

The Planning Office will be working with a small steering committee representing, at a minimum, the Historic Preservation Commission and Tourism Advisory Board with the goal of more appropriately interpreting the historic significance of the Old Stone Chimney / Dean Adams hydraulic canal and the surrounding "RiverView Park" Site through signage and landscape design.

The Niagara RiverView Park Site is an essential component of the City's Waterfront Revitalization Program, fully described in the original study completed in 1988 by Saratoga Associates and approved as part of the City's 2009 Comprehensive Plan.

The City has recently been awarded a Niagara River Greenway Commission grant to work with NYPA, the owner of the Old Stone Chimney and New York State Park Office of Parks Recreation and Historic Preservation to develop a historically appropriate interpretation for the Old Stone Chimney and site. The Niagara River Greenway Commission grant award is in the amount of \$200,000.00.

Other than staff "in-kind" services, no City funds will be used for this project. As such, there is no cash contribution or other cash disbursement required in accepting this award or in completing the Project. Total project expenditures will not exceed \$200,000.00.

Therefore, to effect the intended purpose of the grant, the Department of Planning Environmental & Economic Development solicited proposals for professional services and is now recommending that the proposal from *Trowbridge Wolfe Michaels Landscape Architects LLP* be accepted in the, not to exceed, amount of \$20,835.00.

Will the Council vote to accept the Niagara River Greenway Commission grant, approve the contract award Trowbridge Wolfe Michaels Landscape Architects LLP and authorize the Mayor to execute any documents necessary, in form and in content satisfactory to the Corporation Counsel, to effectuate the same?

### Addendum: Old Stone Chimney History

The Old Stone Chimney is an esteemed relic from the French imperial empire in North America. Once part of a structure known as "Fort Little Niagara," the chimney is the remains of a two-story barrack built in 1750 by Chabert Joncaire. The "Fort Little Niagara" was the terminus of the Niagara Portage trade route which funned all interior North American trade into/out of the Great Lakes region by bypassing the waterfalls and rapids of the Lower Niagara River. Due to its strategic location for movement of raw materials, "Little Fort Niagara" was once the third-most important occupying settlement for France in the New World. During the conflict of the French and Indian War in 1759, the barracks were destroyed in its entirety with the exception of the chimney.

Following the Treaty of Paris of 1763, control over the Niagara Region and portage trade route was handed over to the British Empire. Under the direction of Portage Master John Stedman, the former French barrack's chimney was incorporated into a new "Fort Scholosser." Once more, during hostilities of the War of 1812, the building was burned to the ground in December 1813. Yet, the chimney survived. As time passed, the chimney became one of the United States' last tangible links to both French and British rule. This relic became known as the Old Stone Chimney.

In 1891, a campaign was organized to "save" the Old Stone Chimney from growing industrialization along the Niagara River. Efforts to promote preservation included the popularization of a song written by T.V. Welch, a local friend of Theodore Roosevelt. In 1902, the Old Stone Chimney was carefully dismantled, stones numbered and carefully reconstructed at a new site. This was one of the earliest preservation efforts by the State of New York. The Niagara Frontier Historical Society marked its importance with a bronze plaque in 1915. Nevertheless, industrial expansion on Buffalo Avenue during WWII necessitated relocation again in 1942 to the more appropriate and prominent Porter Park. Unfortunately, the construction of the Robert Moses Parkway in 1962 awkwardly left Porter Park decimated and the Old Stone Chimney in a highway berm. As time went by, the Old Stone Chimney became forgotten and neglected.

With the reconfiguration of the southern section of the Niagara Scenic Parkway (formerly Robert Mosses Parkway), the Old Stone Chimney was once again carefully dismantled at its former Porter Park site and reconstructed at its current location at the former Grass Island/Dean Adams hydroelectric intake. Presently, the Old Stone Chimney stands once again on a more appropriate and prominent site. However, the powerful and significant history is not adequately being told.

The Planning Environmental & Economic Development, Law, and Code Enforcement Departments will be working with the Niagara Falls Planning Board as the Steering Committee along with business owners and other members of the public with the goal of drafting a new updated Sign and Billboard Ordinance.

In updating the Sign Code, the City will establish a new comprehensive system of sign controls governing the display, design, construction, installation, and maintenance of signs. The new Sign Code will be incorporated into the Niagara Falls Zoning Ordinance resulting in a document that is better organized, easily referenced, and more comprehensible by both staff and the general public, while also being reflective of the community's vision.

A brief overview of SPG and its relevant project experience, as well as the proposed scope, timeline, and fee are provided in detail and attached hereto.

In addition to staff-time to supplement this project, funding is currently available in the Tribal Revenue Account. Total project expenditures will not exceed \$25,000.00.


- Review and update of the City's Sign and Billboard Regulations (Chapter 1121); and
- Complete an assessment of the City's Zoning Code (Chapter 1300) to identify necessary amendments to selected sections.

The purpose of this letter is to provide a brief overview of SPG and our relevant project experience, as well as our proposed scope, timeline, and fee. Our philosophy is to utilize past project knowledge and experience to augment and enhance our efforts, rather than duplicate them. Therefore, we have aligned our approach with the desired public meetings, workshops, and deliverables as discussed in our December meeting. We welcome additional negotiation and guidance from your office, if necessary, to ensure SPG captures the best project approach to suit your needs.

### **SPG BACKGROUND & EXPERIENCE**

Founded in April of 2004, SPG set out to provide small and mid-sized communities across upstate and western New York with quality, affordable planning and development services. Now in our 12<sup>th</sup> year of business, SPG has completed over 30 zoning and regulatory-based projects including code updates, amendments, assessments, and project review assistance. ### CITY OF NIAGARA FALLS - CHAPTER 1121 PRELIMINARY ASSESSMENT

Our initial review of Chapter 1121 (Signs and Billboards) has provided us with a preliminary assessment of the City's current regulatory approach, provisions that may be retained, and those that may be found unconstitutional in a court of law. It is our understanding that the City is looking for a newly drafted sign and billboard Chapter that reflects the current vision of the community, improves legality and enforceability, and presents itself in a simple, organized format that is easily referenced by both City Staff and the general public. The following is a brief summary of our initial recommendations to improve the Sign Code.

- + Update sign definitions and remove content-based restrictions.
- → Develop purpose and intent statements that reflect the current vision of the community and modern sign considerations.
- + Ensure required sign permit application and review process is well established in support of a compelling governmental interest and consistent with NYS Municipal Law.
- + Revise current language to reflect content neutral approach, increasing the legal defensibility of the regulations.
- + Provide summary tables for ease of reference of permitted and prohibited sign types and/or classifications by district.
- → Create separate provisions and/or process for the regulation of off-premise signs or billboards.
- ★ Reconcile or incorporate Chapter 315 (Licensing of Billposting and Advertising), Chapter 1107 (Fees for Sign Permits), Chapter 1140 (Political Signs), and Section 317.06 (Tourist Agency Signs) with the newly drafted Sign Code.
- + Review and remove sign regulations from the City Zoning Code (Sections 1321.1, 1323.1.4, 1328.3, and 1328.4), and replace in the newly drafted Sign Code, as necessary.
- → Incorporate newly drafted Sign Code into the City's Zoning Code, if desired, and include graphics, tables, and charts where appropriate.

### CITY OF NIAGARA FALLS - CHAPTER 1300 ZONING ASSESSMENT

As part of this task, SPG will complete a memorandum that provides an analysis of the issues and opportunities associated with the existing Zoning Chapter. In addition, the existing requirements will be compared to recommendations contained in the City's previous plans and studies as well as to national best practices. The memorandum will serve to identify alternative regulatory approaches that should be considered by the City and to prioritize the provisions that should be amended at the current time.

### FOCUSED ON COMMUNITY

### SCOPE OF WORK

Phase 1: Sign & Billboard Code Update — We recommend the creation of a Steering Committee (SC) to oversee this process. The membership of the SC may include representation from the Departments of Planning, Environmental Services, Economic Development, and Code Enforcement, and the City Planning and Zoning Boards, as stated in the RFP previously shared with us. However, we also recommend including local review board members, residents, and property or business owners as part of the Committee. SPG may assist with the staffing of the SC, if desired. The anticipated timeframe for this update is estimated to be a total of six (6) months, including two (2) public meetings and up to four (4) Steering Committee meetings. Descriptions of the proposed tasks and required deliverables are provided in the table below.

<u>Phase 2: Zoning Assessment & Strategic Update</u> – It is anticipated that the zoning assessment will be developed with input provided by City Staff. Once the assessment is completed, SPG will work with the City to determine the number of strategic amendments to be prepared as part of this update process. Subsequently SPG will draft new regulatory language, as necessary, for consideration by City Council. The anticipated timeframe for this effort is estimated to be a total of four (4) months, including three (3) staff meetings.

### **NOT-TO-EXCEED FEE**

Based on the timeline, scope of work, and meetings included in this proposal letter, we have estimated the budget for this project as a not-to-exceed fee of \$25,000. If it is determined that a Sign Regulation Training Session is not required, or a reduction in the total number of meetings is desired, the fee may be adjusted accordingly.

**CHANGE ORDER #5** 

A contract for the above referenced project was awarded to Foit Albert Associates, P.C., on May 29, 2007 in an amount of \$555,000.00. Change Orders request to date bring the total contract amount to \$1,685,197.35

The prime contractor for the Tenth Street/Cedar Avenue project abandoned the job in 2011 before completion and never returned. Since then, the City has settled litigation and can move forward with the remaining funding to correct defective and uncompleted work.

This Change Order covers Professional Engineering Services for design, contract documents, engineering services associated with administering the contract to completion and full time inspection in accordance with the NYSDOT standards specifications and the LAFAP manual.

This project was funded with Federal Highway money as a NYSDOT pass-through project. The NYSDOT is requesting that the project be "closed-out" in order protect the City from having to refund monies we have been reimbursed for earlier work.

The City's Engineering staff has been in contact with Foit-Albert Associates and have negotiated for the services to complete said project in the amount of \$139,000.00

As a Federal pass-through project it is still eligible for reimbursement at the standard 80% -20% split and a portion of funding is also reimbursable under N.Y. State Marchiselli funding.

It is the recommendation of the undersigned that **Change Order #5** be approved in the amount of \$139,000.00 with funding for this change order still available in the original project funding Code H0632.9901.0000.0900.H0632.

> RE: Wage Increases for Lead Parking Attendants and Parking Attendants

Council Members:

The Director of the Department of Public Works ("DPW") is requesting that the hourly wage for Lead Parking Attendants and Parking Attendants be increased. Presently Lead Parking Attendants make \$11.00 per hour and Parking Attendants make \$9.75 per hour. It is requested that the hourly wage for Lead Parking Attendants be increased to \$15.00 per hour and the hourly wage for Parking Attendants be increased to \$11.00 per hour.

These are seasonal employees. The Lead Parking Attendants have taken on all duties related to the new parking meters. Those duties include but are not limited to cash collection, cash balancing, cash deposits, banking, troubleshooting any maintenance issues as well as snow removal on and around the meters. The Parking Attendants new wage no longer includes Step 2, 3 or 4. The proposed increase will meet the New York State minimum wage increase and will remain in compliance through the end of 2018.

Attached hereto is a spreadsheet reflecting the cost of this increase which is anticipated to be \$32,237.41, inclusive of FICA.

Funds are available through budgeted funds. Will the Council so approve?
