#### Disclaimer, Terms & Conditions

- The Annual Parking Permit must be displayed for identification purposes.
- This Annual Parking Permit application is your contract. This contract limits our liability.
- Any car parked at this facility is parked at the owner's sole risk. The owner alone is responsible for parking and locking his car.
- Operator does not guard or assume care, custody or control of your vehicle or its contents and is not responsible for fire, theft, damage or loss.
- Only a license to park is granted hereby and no bailment is created.
- This is not a claim check.
- This is your contract and no employee may modify or waive any of its items.
- If in any case you have lost your Annual Parking Permit card, you are exempt from receiving your deposit.
- There are no refunds.
- This permit is valid only when payment has been made during the designated time period. It will become invalid and not usable if payment is delinquent.
- This permit is assigned to a specific passenger vehicle or SUV and may not be transferred or utilized for a vehicle other than the one it is assigned to. If caught sharing your permit with anyone, you are guilty of **theft of services**. In this case your permit will be revoked permanently and authorities will be notified. The City has the right to revoke the Annual Parking Permit if misuse is determined or for just cause.
- This Annual Parking Permit expires one year from the date of purchase.
- Annual Parking Permit may be utilized any day of the week, any time of day for the three City-owned surface lots: 1. Niagara St. Lot (between First and Third Streets), 2. Third St. Lot (at 256 Third Street), 3. Rainbow Lot (corner of First St. and Rainbow Blvd. lot). as well as at the City-owned parking ramp at 356 N. Rainbow Blvd.
- Permit holder may not be employed at a business located in the downtown area and parking to report to his/her job rather than attending an event or visiting a location in the downtown area.
- By signing this document, you accept and agree to all the preceding terms.

**NO FEE REFUND:** Pass deposit will be refunded upon surrender of pass.
