This is a letter of intent to manufacture and install 2 fabric awnings for Tattlers Lane located at 1519 Pine Avenue. Wy customer does not have a copy of the property survey but I do know that our awnings will be encroaching upon city property from looking at the property lay out. Both of the awnings will have an 18" projection from her building. The lower wider awning will have a minimal clearance of 96" from grade to the bottom of the awning in accordance with NYS code. The upper awning will also project 18" from her building however given that this is a second story awning clearance is obviously well beyond recommendation.
