Mayor Dyster stated that whatever material is left in the buildings that Sandstone cannot use will be sold for scrap value as there is not enough value in the material to sell it at auction.

As the project will be creating many jobs, Mr. Robins stated that the project should be given more press attention. Mr. Vilardo stated that the company is still getting final approvals for a DEC permit and putting things into place. He noted that the project will be made more public in the near future.

# RESOLUTION NIAGARA FALLS URBAN RENEWAL AGENCY Lease with Right of First Refusal of 3625 Highland Avenue Referral to City Council June 27, 2016

WHEREAS, the Niagara Falls Urban Renewal Agency(NFURA) has received a proposal from Sandstone Springs, LLC for the lease with right of first refusal of 3625 Highland Avenue, and

**WHEREAS**, a public notice pursuant to General Municipal Law §570(2)(d) was published in the Niagara Gazette on June 6, 2016 as directed by NFURA

**NOW, THEREFORE BE IT RESOLVED,** that NFURA does hereby accept Sandstone Springs, LLC as a qualified and eligible sponsor for the lease with right of first refusal of 3625 Highland Avenue and be it further

**RESOLVED**, that the lease will be for a period of three years at the annual rate of \$2.50 per square foot for the space occupied, with a minimum monthly rent of \$1,000.00. Utility costs shall be shared *pro-rata* until Sandstone occupies 10,000 square feet, at which time Sandstone shall bear all the costs.

**RESOLVED** that the lease with right of first refusal of 3625 Highland Avenue be referred to the Niagara Falls City Council for its approval after a public hearing
