ACTION ITEMS:

1. <u>Level II Site Plan and Negative SEQR Declaration Approvals:</u> for the project at 4503 Royal Avenue (S.B.L. 160.09-1-9) on behalf of applicant Linde, Inc. Applicant seeks to construct a 35MW hydrogen electrolysis facility as an expansion of the existing plant. The new facility will include seven electrolysis units, a hydrogen purification unit, and a common water feed system.

Anna Knight introduced herself as project leader for Linde, Inc. She stated that Linde was an industrial gas supplier, suppling oxygen, nitrogen, hydrogen, and carbon dioxide all over the United States and the world. The company distributes the products via trucks as liquids or gas. They also do what is called onsite, which is direct gas distribution to a customer. They work with chemicals, steel, glass, pharmaceuticals. Ms. Knight stated that we may have seen some tanks in hospitals for liquid oxygen provided by the company. Linde has over 400 plants and gas generators all over the United States. Linde has 13 pipeline enclaves and Niagara Falls is one of the five hydrogen liquefaction facilities in the US.

Ms. Knight stated that Linde has been at the site in Niagara Falls for over 40 plus years. They currently produce nitrogen, oxygen, argon and hydrogen at this site. She stated that if we looked at the liquid distribution of hydrogen all over United States, Niagara Falls is one of 10 facilities. Linde has over 80 people on the site and has invested significant capital over the last 40 years at this site. The hydrogen feedstock Linde received before was purchased from some of their neighbors. As their market slows down a little bit they are looking for a different feed and that's why they're doing the Electrolyzer Project. The hydrogen demand keeps going up for fuel cells and mobility, to keep up with the demand, Linde will install seven Electrolyzers, which equals 35 of the megawatts that will sustain their demand. This is a \$90 million project, Linde's largest installation, and it will be a showpiece for them.

Ms. Knight stated that the company anticipates that the project will start sometime in December 2024. There will be over 11 new employees and 250 construction and temporary jobs.

Ms. Knight shared the Google map of the existing facility and where the Electrolyzer would be located. She explained that that an Electrolyzer takes water and uses electrolysis to separate water, oxygen and hydrogen. The facility will have water and water treatment in an enclosure, where they will have the seven electrolyzers where it will be separated into hydrogen and oxygen and further purification. Further south is the Power Distribution Center. There will also be a generator in case of a power outage.

Ms. Knight shared the process of engineering and procurement construction. She stated they would take a parallel path and sequential, starting with engineering. When they get approval of all of the currents right, they will start the civil phase and then the mechanical phase, all the way up to the projects roll out.

- Mr. Spanbauer stated that the book they were given for the project was very good.
- **Mr. Palmer** asked the Board if there were any questions or comments.
- Mr. Palmer called for a motion and asked if there were two items that needed votes.
- **Mr. Pesarchick** stated that the Board need a motion to approve the site plan and the negative declaration for SEQR. This would be done as one item.
- **Mr. Palmer** called for a motion for approval for the Site Plan and the SEQR.

A motion to approve the Level II Site Plan was made by **Mr. Nossavage** and seconded by **Mr. Dallavia.**
