Dear City Council:

I am the co-program director for a committee formed for conducting a 5K Walk/Run in Niagara Falls, NY. The I.H.A.V. (I Have A Voice) committee comes in the form of Partnerships. To this end, many involved are concerned organizations in both Niagara Falls and Buffalo, NY these are contributing either monies, or in-kind services such as, consulting, insurance, workers in the form of administrative assistance, material supplies or marketing and public relations production.

We are requesting permission to use City property to conduct the "I HAVE A VOICE 5K WALK/RUN", on Saturday, May 11, 2019, 8:00 am –NOON, to begin at 332 Prospect Street, and end at the Amtrak Station.
