- The Council Chairperson may limit the number of speakers on a topic or agenda item or the overall speaking time if the same will unduly delay the Meeting.
- Speakers must address the City Council as a body. If you would like to address an individual Council Member or anyone else, please do that separately, not during the Meeting.
- Please remain focused on the agenda item you signed up for, or for "the good of the community."
- The Council will not respond to questions or statements that you make during your speech. This is an opportunity to share your ideas, not to engage in conversation or debate.
- This portion of the Meeting is not for personal grievances.
- Use the decorum expected for speaking before an elected deliberative assembly such as the Council.
- The Chairman will enforce these rules.
